The BISWG website was temporarily closed, but is in the process of being reopened so the INSWABI website will soon be available again. For further news,



3. The 6th International Conference on Social Work in Health and Mental Health



This triennial event with the theme 'Changing Health: Acting and Reacting, Challenges for social work theory and practice' attracted over 700 abstracts from around the world. It provided a broad and rich selection of social work topics in health and mental health delivered by social workers across many and varied fields and cultures aiming to enhance and improve their work. The event sought to connect academics and practitioners together in order to stimulate ideas and work on solutions, and ultimately to raise standards in social work for the greater good of all those in need of social work interventions.



Mary McAleese President of Ireland

The official opening address was given by the President of Ireland, Mary McAleese, and centred on the rich and positive contributions that social workers make to society in so many

different ways and the willingness and ability of the profession to respond promptly and appropriately to new challenges thrown up by societies with changing demands. The President endorsed the enduring need for social workers in human services, to protect the rights of individuals and to provide support and services to people and communities on their journeys through life.

Health is a basic right and illness and harm can shatter the lives of individuals and those close to them instantly and irrevocably. Social workers are trained to respond to situations and help to provide solutions aimed at minimising, and in some circumstances preventing, the impact of physical and mental health needs and to help navigate people through systems in order to access appropriate resources.

Issues were explored through plenary sessions, presentations, workshops and posters grouped around six broad headings:

- 1. Service Settings
- 2. Client Groups
- 3. Health through the lifecycle
- 4. Promoting positive health
- 5. Involving service users in policy and practice
- Education/training issues in health and mental health

The plenary sessions focused more on the macro policy issues concerning social work practice, for example, how it tackles global inequality and the challenges for social work to demonstrate and develop its knowledge base in a world concerned with evidence based practice. The presentations and poster displays which ran concurrently, offered a smorgasbord of possibilities. With such a wide choice each opportunity grasped also represented myriad opportunities lost.

The International Network of Social Workers in Acquired Brain Injury (INSWABI) launched at the 5th International Conference in Hong Kong in 2006, has developed during the intervening years and a number of members joined together such that the contribution to the programme of events was centre stage and included a field trip and satellite workshop which was devoted to acquired brain injury (ABI).

With the solid leadership and coordination of Dr Grahame Simpson, a small committee was formed with INSWABI members from Australia, the UK and Ireland to help direct the ABI submissions and to create a working link with Anne O'Loughlin, Head of Social Work at the National Rehabilitation Hospital, Co. Dublin who helped to set up the field trip with contributions from her colleagues. The satellite workshop was presented by Grahame Simpson from Australia and Andy Mantell from the UK after a warm welcome to delegates from the Chief Executive of the National Rehabilitation Hospital.

The field day was followed by a meal hosted by Anne and her colleagues to which INSWABI representatives from Australia, the UK, Ireland, Canada, India, Sweden, and New Zealand were invited and who presented brief accounts of social work practice in their countries. The formation of the INSWABI committee was also a focus of the event.

This was a conference of ideas providing insights into other 'ways of doing' and challenging the 'taken for granted'. It left delegates with as many questions as possible solutions. In our aversion to the potential elitism of the expert, I wonder if we have allowed ourselves to become marginalised and our valuable roles discounted. The last plenary session included a call to arms from Professor Dziegielewski, for social work to lead the way in practice. It is not sufficient to do a good job, we must develop and share the knowledge base

that demonstrates what we do and what we should do.

4. New book on a relational approach to rehabilitation



A new book entitled 'A Relational Approach to Neurorehabilitation' has just been published in the United Kingdom by Karnac books.

The book provides the most extensive exploration to date of

ways to integrate systems theories (from psychodynamic theories through to post-modernist Milan) with neurobehavioural and neuropsychological approaches to neurorehabilitation.

It sets out a rich array of empirical data, an examination of the potential contribution of different types of theories and clinical experience interspersed with case illustrations, practice models and therapeutic strategies.

This book will be of interest to INSWABI members who seek to take a systems-based approach to family work in their ABI practice.

6. The 1st formal meeting of INSWABI

On Wednesday evening 30th June the inaugural INSWABI face to face meeting took place. The meeting started with a formal welcome from Patti Simonson and Anne O'Loughlin. This was followed by a series of national perspectives delivered by INSWABI members from India, Sweden, Canada, New Zealand, Ireland, the UK and Australia.
